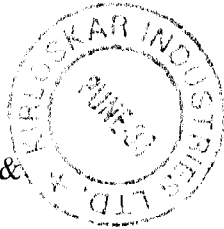
During the period, from 26 April 2012 to 18 May 2012, composition of the Board of the Company was not consisting of half of the Board as Independent Directors.
